- Must be certified as a Virginia State EMT prior to the start of class. Out of state applicants or those with national certification only need to gain temporary reciprocity from the VA Office of EMS
- Monday & Wednesday nights from 1800-2200 with intermittent Saturdays and Sundays from 0900-1700.
- Course Tuition: \$6999 which includes:

  - Cadaver Lab
  - iPad you will own
  - 2 Student Polos

## **Additional Course Cost:**

- AEC requires a mandatory national background check and 12-panel drug screen through [www.castlebranch.com](http://www.castlebranch.com). The current cost for this is \$82.00 and must be completed no earlier than 30 days before the class start date. AEC will provide the necessary instructions after the student has registered.
- Fisdap - Scheduler and Skills Tracker - \$84.00 (due dates and procedure will be explained during orientation)
- Fisdap Paramedic Comprehensive Exam - \$26.25 (due dates and procedure will be explained during orientation)
- National Registry Psychomotor Exam - \$250.00 (due dates and procedure will be explained during orientation)
- National Registry Computer Based Test - \$125.00 (paid directly to NREMT after passing class)
