Additional Course Cost:

- AEC requires a mandatory national background check and 12-panel drug screen through www.castlebranch.com. The current cost for this is \$82.00 and must be completed no earlier than 30 days before the class start date. AEC will provide the necessary instructions after the student has registered.
- Fisdap - Scheduler and Skills Tracker - \$84.00 (due dates and procedure will be explained during orientation)
- Fisdap Paramedic Comprehensive Exam - \$26.25 (due dates and procedure will be explained during orientation)
- National Registry Psychomotor Exam - \$250.00 (due dates and procedure will be explained during orientation)
- National Registry Computer Based Test - \$125.00 (paid directly to NREMT after passing class)
